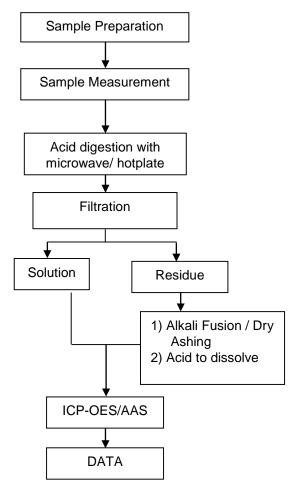



Hexavalent Chromium (Cr(VI)) Testing Flow Chart







#### **PBBs/PBDEs Testing Flow Chart**





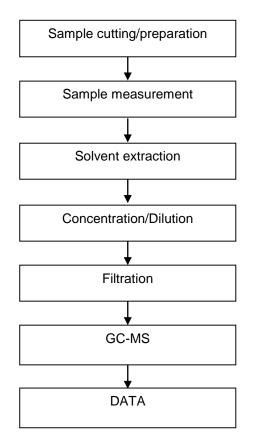

#### **Phthalates Testing Flow Chart**







